## **Healthcare: An Industry in Transition**

The U.S economy has continued its long trek back to growth, and the healthcare industry sits at the core of this expansion. In the majority of communities across the country, healthcare is the fastest-growing business sector- by far. In the Hudson Valley, healthcare has contributed over \$15 billion to the regional economy, and the job outlook is very positive. At the same time, hospital consolidation has been on the rise since 2010, as the Affordable Care Act requires hospitals to transition from a traditional fee-forservice model to a reward system that recognizes positive outcomes. Some officials have said compliance under the law will be easier with greater scale, and further a consolidation trend fueled by declining hospital patient volume and tighter finances. Out of the 5,000 hospitals in the U.S., more than 60% are now part of larger hospital systems. The pace of hospital mergers has accelerated even further here in New York in recent years, creating ever larger networks. According to Crain's, New York City hospitals "seem to have a thing for suburban Westchester County", as



In a recent report from the Alliance for Health Reform, 78 percent of hospitals were either exploring a merger or in the midst of one.

they have covered the rapid acquisitions of other hospitals by New York-Presbyterian Healthcare System, Montefiore Medical Centers, Mount Sinai Health System and the North Shore-LIJ Health System. Montefiore recently announced that White Plains Hospital will become an affiliated facility, and New York-Presbyterian acquired Lawrence Hospital in Bronxville and Hudson Valley Hospital. The few remaining independent healthcare systems are expected to merge by the end of 2015.

#### **HRG Awarded Workforce Attributes Contract**

Hospitality Resource Group was awarded a 1 year contract by the County of Westchester to develop curricula and coordinate communications to support workforce development programs for youth services organizations throughout the County.
